2. Natural Disaster Prevention / Crime Prevention

Prevention for Earthquake and Natural Disaster

Crisis Management Division Tel: 0533-89-2194

In Toyokawa, Nankai Trough Earthquake is considered as one of the biggest concerns. It is called trench-type earthquake as Great East Japan Earthquake which is caused by distortion of plate covering earth. It is said that it might occur in the next 30 years with 80% of certainty and its scale would be M9.0-M9.1, seismic intensity 5-6. Also, many typhoons attack this area from summer to fall. When earthquake or typhoon hits here, public transportation might stop. Elementary and junior high schools and public facilities are designated as emergency evacuation sites in Toyokawa. If you feel danger staying at home due to the natural disaster, you can temporarily use evacuation sites. In case of evacuation order, get evacuation information using Anshin Mail, Toyokawa City Disaster Prevention App, rental home receiver etc. and evacuate to the evacuation site which is open.

■Disaster Prevention Drill

Every year, total disaster prevention drill is conducted in Toyokawa. In addition to the participation of Toyokawa Fire Department, Police Department and Self-Defense Force, the practical drill is conducted in cooperation of voluntary organizations, such as voluntary disaster prevention societies, disaster prevention leaders and disaster prevention volunteer coordinators. The date for the total disaster prevention drill will be posted on Toyokawa Newsletter. Please have a look and understand what to do in times of disaster. September 1 is "Disaster Prevention Day". Let us participate actively in the local disaster prevention drill to protect yourself and loved ones.

■Emergency carry-out Items

Let us prepare things of immediate need after disaster occurrence in a bag etc. The possible carry-out weight is about 15 kg for adult man and 10 kg for adult woman.

Things to prepare

Evacuee register (Fill in the form in advance.) Drinking water, Emergency Food (for 3 days), Portable radio, Flashlight with spare batteries, Plastic bags/Garbage bags, Sanitary goods, Clothes, Work gloves, Glasses, Towel, Tissue paper, Wet tissue paper, Rain gear, Winter clothing, Matches, Lighter, First-aid kit, Household medicine, Medication record book, Food wrap film, Writing materials, Newspaper, and Valuables (cash, bankbook, driver's license and INKAN), portable toilet etc.

For a household with elderly or nursing caretaker(s) etc.

Food, Disposable diapers/underwear, Medicine for chronic disease etc., Cane, False teeth, Reading glasses, Family's contact, Personal identification, Disability certificate, Mouth wash, Denture cleanser, Nursing care products, Hearing aid etc.

For a household with a pregnant woman or infant(s)

Disposable diapers, Nursing bottle/Disposable nursing bottle, Wet paper towels, Baby carrier, Breastfeeding cover, Blanket, Maternity passbook, Gauze handkerchief, Breast pad, Clothes for infant(s), Toys, Paper cups, Spoons, Health insurance certification, Copy of recipient certificate for child medication, Baby food, Powdered milk, Drinking water, Snacks and Allergy-free food etc.

■Stockpile for Emergency

Store food for more than 3 days (if possible, for 1 week) and drinking water (3 liters per person a day), plastic bags (for garbage and filth), portable gas stove and so on at home. To store food, purchasing not only special preserved food but also food such as instant noodles, snacks and bread in addition when going shopping for daily things. It is a way of stockpile to refill what is consumed.

■Earthquake-resistant reinforcement for housing

A massive earthquake might hit your house and cause damage to it. Get earthquake-resistant reinforcement to your house to protect your life and property.

■Furniture fall prevention

Furniture fall can be a cause of injury and become an obstacle to evacuation. Check the safety in your house regularly.

■TOYOKAWA ANSHIN MAIL

Toyokawa Anshin Mail is the information about disaster and city administration etc. sent by E-mail to your registered mail address of mobile phone and PC (multilingual translation). Weather information such as heavy rain, storm and Tsunami warning is automatically distributed as soon as it is announced by Meteorological Agency. Access the city website from QR code on the right and register.



■Toyokawa City Disaster Prevention App

"Toyokawa City Disaster Prevention App" is Toyokawa city official disaster prevention app. Many kinds of information such as disaster information and broadcasting from outdoor speakers can be received by this app. Please make use of the app as "Portable Disaster Prevention Measures". From respective store, search "豊川市防災アプリ(とよかわし ぼうさい アプリ)/Toyokawa Shi Bosai Apuri" and install the app or install from the QR codes on the right.

■Communication method for emergency Voice Mail Service for Disaster, "171"

When a natural disaster strikes, it will be hard to communicate with a general subscriber telephone line. When you want to confirm someone's safety, use NTT's voice mail service for disaster or respective cellphone company's message bulletin for disaster.

- **How to record (within 30 seconds):** 171 → 1 → telephone number
- **How to play back message (within 30 seconds):** 171 → 2 → telephone number

■Let us have disaster prevention meeting with your family

To prepare for earthquakes, let us talk about the way of self-protection with your family. In addition, let us check the contact methods in case of disaster occurrence when you go out for work or school etc.

- **Division of roles of family members:** Each member's role in times of earthquake
- **Check dangerous spots:** Check roof tiles and antennas. Are certain flowerpots fixed in the balcony?
- **Ensuring safe space:** Are preventive measures taken for furniture fall and glass shattering?
- **Check the emergency carry-out items:** Do you have everything you need? Check storage condition and expiration date.
- **Check contact method and evacuation site:** How to contact when your family is separated. Confirm evacuation site and evacuation route

Neighborhood Association, CHONAIKAI International and Civic Activity Division Tel: 0533-89-2165

Neighborhood association, CHONAIKAI, is conducted by the residents who live in the same area. CHONAIKAI deals with various matters such as disaster prevention, crime prevention, traffic safety, garbage collection and so on. It aims for improving welfare of the residents. It also provides the residents with daily life/public information. Let us join the neighborhood association, CHONAIKAI.

Link to Safety and Relief Map of Aichi prefectural police is made to enable to see the latest information about suspicious person on the city website. Additionally, police stations implement "Pato Net Aichi" providing suspicious person's information etc. by E-mail in police-station units to the registered persons. For registration method etc., see the website of Aichi prefectural police.

Distribution of crime prevention information from School

Each elementary and junior high school distributes information to guardians and school guards who request it. In addition to crime prevention information, educational information is distributed.).

3. Resident Registration/Family Register

Resident Registration

On Basic Resident Register, each citizen's name, address, date of birth, sex and so on are recorded. When you change the address or the householder, you need to file for it. The same procedure is required to foreign residents as well.

※Bring your identification (My Number Card, residence card, passport, driver's license etc.).

※Bring My Number Card since relevant information needs to be written on the card.

※In the case of application by an agent, not only a letter of proxy but agent's identification (such as My Number Card, residence card, passport, driver's license) is required.

※You can mail the moving-out notice. When you mail it, enclose ① notification form (date of moving-out, new address, address in Toyokawa, name, and daytime telephone number must be written in) ② Return-mail envelope (Put a stamp)

③ Copy of identification (such as My Number Card, residence card, passport, driver's license), ④ Seal registration certificate (Those who registered) and National Health Insurance Card (only the member), then mail it to the Civic

Affairs Division.

※Also, when you move out from Japan, the moving-out notification is necessary (If you have re-entry visa, it is not necessary.).

※Office Hour: 8:30 am – 5:15 pm (10:00 am – 5:00 pm at Prio Service Center)

No service on Saturdays, Sundays, holidays and Year-End and New Year Holidays

※Foreign resident means person with another nationality who has mid- and long-term legal stay in Japan or special permanent resident.

Registration of Birth, Marriage and so on

If there are any changes in your family such as childbirth, death, marriage, divorce and so on, register it to the Civic Affairs Division.

Birth Registration	Register childbirth to the Civic Affairs Division within 14 days after the birth. Bring a birth registration form with birth certificate, issued by a doctor or a midwife, INKAN, maternity passbook, and health insurance card. *It must be registered by the father or the mother of the child.
Marriage Registration	In a registration of foreign national's marriage, the procedure varies depending on the nationality. Make sure to consult with a staff member at the Civic Affairs Division in advance.
Divorce Registration	In a registration of foreign national's divorce, the procedure varies depending on the nationality. Make sure to consult with a staff member at the Civic Affairs Division in advance.
Death Registration	Bring death certificate and submit death registration form to the Civic Affairs Division. The national health insurance card and so on must be returned at the same time. It also must be reported to the consulate of the nationality of the deceased.

Residence Card (Zairyu Card)

Alien Registration Act was abolished in July 2012, and it turned into the Basic Resident Register system for foreign residents.

Eligibility

Person with another nationality who has mid- and long-term legal stay in Japan or special permanent resident, excluding short-term stay

How to renew a residence card

Renewing residence card etc. can be done at immigration bureau. For further information, contact immigration bureau.
※Please bring your residence card for the procedure.

Seal Registration (INKAN Toroku)

Eligibility

Those who are registered in the Toyokawa City Basic Resident Register, aged 15 or older and have mental capacity. Only one INKAN, seal, can be registered per person. A married couple cannot register an INKAN, seal, in common.

Required items for registration

① INKAN, seal (Rubber seal, chipped seal, seal whose image seems same with another family member's, or worn seal cannot be registered.)

② Your identification (My Number Card, residence card, driver's license, passport etc.)

Place where you can do seal registration

Civic Affairs Division, Ichinomiya, Otowa, Mito, Kozakai branch office, Prio Service Center

Various Certificates

Various certificates are issued (Charged). For the application, the identification (such as My Number Card, residence card, driver's license, passport etc.) is required. In case of application by an agent (For residence certificate [Jyumin Hyo], person other than the applicant or same household's family member, and for family register [Koseki Tohon] etc., person other than the applicant, its spouse, lineal ascendant, or lineal descendant)," a letter of proxy" is necessary. INKAN, seal, registration card is needed to issue Certificate of Seal Registration (For Certificate of Seal Registration, application by a third person is acceptable, and a letter of proxy is not necessary.).

Use issuance service at convenience store

By using My Number Card, respective certificates can be obtained with multi-functional copy machine at convenience stores throughout the country.

Eligibility: Person who has My Number Card installed with digital certificate for user certification, and has resident register or permanent address in Toyokawa.

Hour: 6:30 am – 11:00 pm (Except maintenance day)

How to use: Choose “行政サービス”(Administration Service) on the display of multi-functional copy machine, and follow the instruction guide. It is necessary to scan My Number Card, enter PIN code (four-digit number), choose certificate, and pay the fee.

Available certificate (For those who have resident register, seal registration, permanent address in Toyokawa)

- Copy of Residence Certificate (Jumin Hyo) of the applicant or the household member: 200 yen per copy
- Certificate of Seal Registration (INKAN Toroku Shomeisho) of the applicant: 200 yen per copy
- Certificate of Family Register of all registered members or individual member (Koseki Tohon/Shohon) for the applicant and registered member: 450 yen per copy
- Copy of Family Register's Attachment (Koseki no Fuhyo) for the applicant and registered member: 200 yen per copy

※Exchanging certificate or returning the fee is not possible.

※Available certificates are latest ones, and certificates of deleted residence record (Jumin Hyo Johyo), removal from register (Joseki) etc. are not available. In case of change such as marriage and moving-in, it may take several days until certificate issuance is ready.

My Number (Individual Number) Card

Since January 2016, the issuance of My Number Card has started. My Number Card is issued by the person's application and can be used as official ID document for the proof of individual number and the person's identification. It is an IC card with which a person can receive various administrative services.

※In case that a child under 1 year old applies, My Number Card without face photo is issued. Therefore, a face photo or a digital face photo is not necessary.

※It will take 1.5 – 2 months when "Issuance Notification" is delivered from your municipality. The applicant in person is requested to come with necessary documents written on the Issuance Notification to receive My Number Card.

※If application form for issuance is not at hand, it can be re-issued at the municipality of your residence certificate.

Necessary things to bring

- My Number Card Issuance Notification (Post card enclosed with information leaflet)
- Notification Card (Only those who have it)
- My Number Card which is close to expiration date (Charge will occur if you cannot bring it.)

【ID document】

①	Official public ID document with face photo Ex: Driver's license, residence card (with face photo), passport, special permanent resident certificate etc.
②	ID document with applicant's name and address, or name and date of birth Ex: Health insurance certificate, certificate of qualification confirmation, certificate of long-term care insurance, pension booklet, employee ID, student ID etc.

One of ① or two of ② will be necessary to receive My Number Card.

※About ID document

- ID document whose name and address are the latest ones corresponding to the person's residence certificate
- Expired documents cannot be used for the person's ID.
- Please show original documents.

4. Tax/Tax Certificates

Resident Tax

Resident tax consists of prefectural resident tax and municipal resident tax. The amount of resident tax is calculated based on the income of the previous year. The resident tax is paid to the office of the municipality where you lived on January 1. If you work for a company, this tax is withdrawn from your salary. However, if you do not work for a company and you run your own business, a tax payment slip is sent to you from the city hall in June.

Light Vehicle Tax

The light vehicle tax is imposed on those who possess a motorized bicycle, light vehicle, small-sized special motor vehicle or small two-wheeler vehicle with regular parking place in Toyokawa on April 1 every year. Payment slip is sent around the middle of May.

※For automobile tax (which is a prefectural tax imposed on those who possess standard-sized cars etc.), payment slip is sent around the beginning of May, and you pay at financial institution, convenience store etc.

Payment method: Resident Tax, Light Vehicle Tax, and Real-Estate Tax

You can pay the tax at the designated financial institutions (Toyokawa Shinkin Bank, Mitsubishi UFJ Bank, Himawari Nokyo, Bank of Nagoya, Toyohashi Shoko Shin-jo Kumiai, Gmagori Shinkin Bank, Toyohashi Shikin Bank, Okazaki Shinkin Bank, Tokai Rodo Kinko, Japan Post Bank [Limited to Aichi, Gifu, Mie, and Shizuoka prefecture.]), City Hall, Ichinomiya, Otowa, Mito, and Kozakai Branch Office, Prio Service Center, and designated convenience stores (only for an amount not over 300,000 yen).

In case of the payment slip with eL-QR, you can pay at the counter of nationwide financial institutions providing eL-QR service, or you can make a cashless payment by credit/internet banking/smartphone etc.

If you have an account at a financial institution designated by the city, you can request the account transfer for tax payment. Bank account transfer is recommended to save your time for the payment. For requesting bank account transfer, bring your bankbook and seal (INKAN) used to open your account, to the designated financial institution where you have an account.

When a taxpayer meets the following conditions, reduction/exemption and due date extension of **resident tax/light vehicle tax/real-estate tax** might be accepted.

Resident Tax: The taxpayer is on welfare, or he/she is notably facing financial difficulties without income.

Light Vehicle Tax: The vehicle owned by person with physical disabilities etc., the vehicle remodeled for the use of person with physical disabilities.

Real-Estate Tax: The taxpayer is on welfare or a victim of disaster.

Due Date Extension of Tax Payment: The taxpayer cannot pay the tax by the due date because of illness or injury of the taxpayer or its family member sharing the same livelihood, or loss of property caused by disaster/theft etc.

Please cooperate to pay the tax by the due date.

Late payment charge might be added for overdue tax payment, such as **resident tax**, **light vehicle tax**, and **real-estate tax**. If the tax remains unpaid, your property might be seized. Please cooperate to pay the tax by the due date.

5. Education/Child-Rearing

Nursery School/Certified Kodomo-en (category 2 and 3)/Small Childcare Establishment

To enter nursery school for next school year, the application is accepted around beginning-middle of October every year. The eligible child must have the following guardians who cannot take care of the child during daytime. (1) Having a job outside the home. (2) Having a job at home except for housework. (3) 8 weeks before and after childbirth (in case of multiple pregnancy, 14 weeks before childbirth). (4) Having disease or mental/physical disability. (5) Giving care to, or nursing a family member in the same household constantly. (6) Recovering from disaster. (7) Looking for a job (only for the first 3 months of the enrollment). (8) Going to vocational training school or university. (9) Other: The necessity of childcare is recognized by the mayor. Other than above-mentioned cases, applications are accepted at any time.

Kindergarten/Certified Kodomo-en (category 1)

There are 5 private kindergartens and 3 certified Kodomo-en in Toyokawa. Applications for enrollment are accepted in October every year. Please apply for enrollment by using application forms which are available at kindergartens etc.

Elementary School

Eligible children are aged 6, born between April 2 and April 1 the following year. Guidance of medical checkup for new students, and school entrance notifications are sent to the guardians from the Board of Education.

■ Medical checkup for new students:

Notification is sent around September in the previous year of enrollment. Please have a medical checkup on the designated date and at the designated elementary school.

■ School enrollment notification:

School enrollment notification is sent by the end of January of the year in which the child enters the elementary school.

Transfer from a school outside of Toyokawa to a school in Toyokawa

After the resident registration, submit the document for transfer received from the previous school to the School Education Division, the Child Rearing Support Division, Ichinomiya, Mito, or Kozakai Branch Office.

Jido Club

This project provides after school childcare for elementary school students whose guardians are not at home due to work and so on.

【Date and Hour】

Week days: Until 6:00 pm / Spring, Summer and Winter Holidays: From 8:00 am to 6:00 pm. If you require, it is available until 7:00 pm. (In the case, application is necessary.) ※There are exceptions partially (Closed on Saturdays, Sundays, national holidays in April and May, Obon holidays, and Year-End and New Year Holidays).

【Eligibility】

Elementary school students whose guardians are not at home after school

【Fee】

The monthly fee is 7,500 yen (13,000 yen in August) (If you require overtime childcare, 1,000 yen is added each month.). ※There are exceptions partially.

【Application】

Fill in the designated application form and submit it to the Child Rearing Support Division. Regarding the Jido Club operated by the Guardian Association (Mochinoki, Skip, Friend, Flap, Kids, Sakura, and Tsubame), directly apply to each club.

Child Allowance, JIDO TEATE

Child allowance is paid to a person who has custody of, or raises a child up to the first March 31 after the child becomes 18 years old. Application at the counter is necessary for receiving Child Allowance.

【Sum of the payment】

Under 3 years old: 15,000 yen per month / 3 years old and older up to the end of 18-year-old fiscal year: 10,000 yen per month (From the 3rd child, 30,000 yen)

【In the following cases, the report is necessary.】

- (1) When the number of children increased due to birth and so on.
- (2) When you stop raising children or live separately.
- (3) When you change the address, name, bank account and so on.

6. National Health Insurance

National Health Insurance

Insurance and Pension Division (National Health Insurance Benefit Section) Tel: 0533-89-2135
(National Health Insurance Premium Section) Tel: 0533-89-2118

The purpose of this public medical insurance is mutual aid that the insured persons pay money (premium) in advance and spend the money for medical care charge. Those who have a residence certificate in Toyokawa, except a person who is on welfare or the insured person of other health insurance, must join the National Health Insurance.

Application for joining National Health Insurance is recommended as soon as you become eligible.

The day of joining National Health Insurance is the day of moving in, the day of leaving welfare benefit plan, or the day when you lost qualification of social insurance and so on. It is not the day when you file for it. Please do your filing **within 14 days** of the occurrence of reason for applying for the qualification. If the filing is late, the insurance service is not available for that period, but the insurance premium occurs from that point of time (2 years maximum), and the medical expense during this period needs to be fully covered by the person.

Procedure for National Health Insurance, NHI

The procedure is required within 14 days of the following occasions.

※For the registration, householder's, and applicant's My Number (individual number card or notification card etc.) is also required. When you join National Health Insurance (NHI hereafter), My Number of your family member who is already joining NHI, is also required.

※When you join social health insurance at your working place etc., NHI cannot cover your medical expenses from the day of obtaining eligibility for social health insurance. Please be aware that if you used NHI, that part of medical expense needs to be paid back.

Insurance Premium

National Health Insurance premium is determined in August based on the previous year's income and the number of subscribers. The premium is divided in eight-time payment. All the related payment notification will be mailed to the householder who is a tax debtor. For person aged 40-64, insurance premium for nursing-care is added to insurance premium of medication / support for late-stage senior citizens. Reduction of the insurance premium is available if the household's previous total annual income does not reach the standard. There is also a system for reduction/exemption of the insurance premium.

Available benefits and allowances of NHI, National Health Insurance

If you show your NHI card at the counter in a hospital, you pay 20-30% (the rate depends on your age) of your medical fee and NHI covers the rest of the fee. If you apply, you can receive medical expenses, high-cost medical care benefits, transportation benefits, childbirth lump-sum allowance, funeral benefits and additional medical support benefits for tuberculosis.

7. National Pension/Long-Term Care Insurance

National Pension (Kokumin Nenkin)

Insurance and Pension Division (National Pension Section) Tel: 0533-89-2177

Everyone who lives in Japan aged between 20 and 59 is obliged to join the National Pension Program. This program provides basic pension to the elderly, the disabled due to disease or injury, and widows/widowers etc. to help them financially. When you become 20 years old, "Information on joining National Pension", "Notification on basic pension number", "Payment slips of National Pension premium" etc. are sent to you from the Japan Pension Service within 2 weeks approximately.

Pension Premium

The amount of pension premium is fixed and amended every year regardless of income and age etc. of the insured person. Some reduction systems are available for persons who have difficulties with the payment. Payment slips are sent from Toyokawa Pension Office (Tel: 0533-89-4042). In the case of advance payment and bank account transfer, reduction is also available.

Employees' Pension

The Employees' Pension Scheme has been designed to add the benefit to that of the National Pension, for the life after retirement. When you are employed by a company or an organization, you join this program. The premium is paid half and half by the employer and the subscriber.

Lump-Sum Withdrawal

You can receive some amount of lump-sum withdrawal when you go back to your country. The application form is available at Toyokawa Pension Office. Fill in the form and send it to the Japan Pension Service within two years after you left Japan. However, when you leave Japan with re-entry permission, you cannot apply for a lump-sum withdrawal within the valid term of the re-entry permission or during stay.

Long-Term Care Insurance (Kaigo Hoken)

Elder Care and Nursing Division Tel: 0533-89-2173

Long-Term Care Insurance System (Kaigo Hoken)

This is a system of insurance to support people who require care with entire society.

Eligibility

People aged 65 and older (Category 1 insured persons)

People aged 40-64 covered by a health insurance program such as company's health insurance and National Health Insurance (Category 2 insured persons)

Insurance Premium of Long-Term Care Insurance

People aged 65 and older (Category 1 insured persons): The insurance premium is deducted from pension benefit (old age/retirement/disability/survivor's pension), or paying by payment slip or bank account transfer is required.

People aged 40-64 (Category 2 insured persons): The insurance premium is determined based on the calculation method of the person's medical insurance and collected together with the health insurance premium.

Long-Term Care (Long-Term Care Prevention) Service

Long-Term Care Service is provided to a person who is certified as care level 1 to 5 (The level 5 is the severest.).

Long-Term Care Prevention Service is provided to a person who is certified as support level 1 or 2. This service aims to stabilize and improve support level 1 & 2 person's functioning.

8. Housing/Water Supply

■Application for Municipal Housing, SHI-EI JUTAKU

【Eligible Applicants】

- (1) The applicant has a residence or working place in Toyokawa.
- (2) The applicant has a family who is living together or will live together with the applicant (Common-law marriage and fiancé[e] are included.).
- (3) It is apparent that the applicant and its family currently have housing problem.
- (4) The applicant's income meets the requirement income standard in the bylaw of Public Housing.
- (5) The prospective residents do NOT belong to any crime syndicates.

【Periodic Application】

The periodic application is announced on "Toyokawa Newsletter" of April 1, July 1, October 1 and January 1 edition, and the city website. The residents are selected by lottery after application.

【Occasional Application】

This means first-come-first-served application. For further information, contact the Building Division.

■Application for Prefectural Housing, KEN-EI JUTAKU

There are two ways; first-come-first-served basis and lottery.

1) Application for first-come-first-served basis

Application Period: March-June, July-October, November-February

Application Method: Bring the necessary documents to each prefectural housing management office.

2) Application for lottery

Application Period: January, May, September

Application Method: By postal mail

【Eligible Applicants (In General)】

- (1) The applicant has a family who is living together or will live together with the applicant (Common-law marriage and fiancé[e] are included.).
- (2) It is apparent that the applicant and its family currently have housing problem.
- (3) The applicant's income meets the requirement income standard in the bylaw of Aichi prefectural housing.
- (4) The applicant (including the family members who are living with the applicant) does NOT belong to any crime syndicates.
- (5) The applicant has no unpaid house rent, compensation for damages and other unpaid expenses of prefectural housing contract.

※The application form is available at the Building Division in Toyokawa City Hall (North Bldg. 4F). Depending on the situation, more documents might be required. In addition to "In General", there are categories of "Welfare" and "Closer Living Arrangement". For further information, contact the place below.

Water Leak

When you need to fix water leaking in your house, contact a plumber designated by the city (You have to pay the expenses.). About designated plumbers, see the city website. For underground water leakage etc., water which leaked may be partially reduced for the water bill calculation (Reduction for all the leaking period is not possible.). For more information, contact Toyokawa City Water Bill Customer Center (Payment) (Tel: 0533-93-0151).

9. Garbage

Type of Garbage and Garbage Collection Days Waste Management Division Tel: 0533-89-2166

Please correctly sort out garbage and put it at garbage station of your residential area from sunrise by 8:30 am on the garbage collection day following the disposal rules.

The garbage collection day is determined in each school district and community. Confirm the place where the garbage collection site is. First, let's confirm in which district your house is.

The Waste Management Division provides Rules for Separation of Household Garbage and Recyclables and How to Put Them (In 6 languages: Portuguese, Spanish, English, Chinese, Vietnamese, and Indonesian) and distributes Garbage Separation App (In 4 languages: Portuguese, English, Chinese, and Vietnamese) where rules are explained for separation of burnable garbage, non-burnable garbage, hazardous garbage, recyclables (plastic bottles, cans etc.), and oversized garbage, and how to put them.

【Burnable Garbage】 (twice a week) ※Put the garbage in a designated bag of burnable garbage.

Food garbage (Drain the garbage off.), wood waste, plastic containers, Styrofoam and so on.

【Non-burnable Garbage】 (twice a month) ※Put the garbage in a designated bag of non-burnable garbage.

Ceramics, small home electrical appliances (such as hot pot and steam iron), kitchen knives, sheet glass, umbrellas,

light bulbs and so on

【Hazardous Garbage】 (Once or twice a month, it varies depending on the region.) ※Put them directly in the box without using a bag.

Spray cans, gas lighters, fluorescent tubes, mercury thermometers, batteries, rechargeable batteries, button batteries

【Recyclables】 (once a week) ※For paper, used clothes, towels, and white Styrofoam trays, do not put them on rainy day.

Metal items, cans, bottles, paper, used clothes, towels, plastic (PET) bottles, white foam trays

Garbage Separation App “San Aru (3R)” (In 4 languages : Portuguese, English, Chinese, and Vietnamese)

It is a free app for easy use with functions for searching garbage collection days, how to separate, and letting you know recyclables and garbage collection days. (Communication fee is to be paid by the user.)
